

## Clarification of OIC Regulations Surrounding Shotguns in Canada

There has been great debate over how the new Order In Council (OIC) regulations affects various products in Canada, with 10 and 12 gauge shotguns taking up a significant portion of that debate. Clarification has been given, both by Ministers during Parliamentary sessions and now on the RCMP's OIC summary page, however, the law as it is written, has not been repealed or amended!

10 and 12 gauge shotguns remain for the most part untouched by the new regulations

Products like the Typhoon F12 Modern Sporting Shotgun and Hunt Group FD12 Bullpup remain properly classified as non-restricted.

Thousands of other 10 and 12 gauge shotgun platforms used daily by the legal firearms community remain non-restricted.

### NEXT STEPS

A change of government is the only surefire way to have the Order in Council and other punitive legislation like Bill C-71 repealed.

The deadline to register as a member of the Conservative Party of Canada with voting rights (membership is only \$15.00) in the leadership race is Friday May 15, 2020.
